Item 6: L/Y Park - Frisbee Golf Course Update

Bob Bazin said all the parts are in and we are down to installation. It was mentioned that a consensus needs to be made concerning course layout. Nothing can be installed until it is determined where the goals shall be placed. It was suggested that George Bazin and Craig Hufferd (Public Works) are working together to determine the most effective course layout. At this point we are at a standstill until this is determined.

Item 7: Individual area of responsibility updates:

- ➤ Bob Bazin (Chairperson) Nothing to report
- ➤ David Maddax (Aquatic Center) Maddax stated his granddaughter (Logan Johnsen) was a Manager at the Aquatic Center this summer. She told him that the 2020 Aquatic Center swim season went extremely well despite COVID-19 restrictions and concerns.

Maddax also mentioned that he was sorry for not attending recent meetings. - ➤ Wayne Knop (Ron Weers Park) Knop asked if the aeration system at City Lake is still under warranty. Administrator Law said the system is currently under a maintenance contract. Knop mentioned that the system has been intermittent. One week the aeration system is working the next week its not working. Knop has been told by sources that one of the hoses connected to the pump is loose and the pump is so hot it cannot be touched. Administrator Law said Staff will reach out to the company and have it evaluated.

- ➤ Diana Moore and/or Amy Buffington (Louisburg Rec Commission) Moore mentioned that the Rec Commission had its first soccer games last weekend. It was recommended that the city place signs in area to deter this type of action. It was also suggested that additional dog waste stations be placed in the park.
